Rules & Regulations

- Parents and spectators are not allowed to enter in the playing area while the match is in progress.
- Total of 9 games to be played in each match. The individual who reaches 9 games first will be declared winner.
- Rules will be cleared prior to start of match if required by participants.
- All participants must report 30 minutes prior to match. Failure to do so will result in forfeiture.
- Every participant will independently check in. The relevant information will be displayed on the noticeboard. Upon check-in, individuals are required to present their identification at the coordinator desk.
- No empire will be assigned to the match. You will be calling your shots. A scoreboard will be provided to each participant prior to the commencement of the match. Participants are required to complete the sheet either upon completion or as they progress, using readable writing. At the conclusion of the match, it is required that participants submit the completed and signed scoresheet to the coordinators.
- In case of dispute, parents are not allowed to interfere. A coordinator must be called to resolve the dispute. Coordinator decision will be final.
- Participants are expected to demonstrate mutual respect towards one another and the coordinator. We strictly prohibit the use of offensive language. In the event of a guilty verdict, disqualification will ensue.
- Pakora, Chai and langar will be served at the venue.
